Product Specification: Beck 16.5 lb. (7,5 kg) Beck Liner®

<u>Measurements:</u>	481 x 253 x 60 mm.
<u>Liner weight:</u>	Average weight: 145g ± 6g
<u>Block weight:</u>	16,5lbs or 7,484 kg ± 55g/Estimated Block dim.: 482 x 254 x 62,7 mm. (9 x 10 x 2,5 inches)
<u>Frame dimensions :</u>	485 x 255 x 59 mm
<u>Intended use:</u>	<p>As a protecting inner liner when freezing and storing human foodstuffs, mainly fish, chicken, vegetables, and fruits in blocks. The Beck Liner is suitable for packaging of fresh or single frozen foodstuff at a temperature below -18°C. Freezing to be commenced no later than 60 minutes from packing. However, the recommendation is to start freezing within 30 minutes. The temperature of the frozen foodstuff must be below -18°C.</p> <p>The frozen foodstuff must not be defrosted in contact with the Liner.</p> <p>The liners are NOT reusable.</p>
<u>How to use the liner:</u>	<p>Please refer to the Beck Food Block Manual. (Available on: www.beck-liner.com) Beck Pack System will not guarantee for the liner performance if the wax barrier is broken.</p>
<u>Material components:</u>	
➤ Cardboard:	<p>Paper consisting of 100% recycled cellulose fibres Steering chemicals such as: Starch, Sizing agents, dyes and process additives. All based on products free from additives of animal origin.</p>
➤ Wax Coating:	<p>Mainly hydrocarbon wax with max. 0.5% oil content (measured as MEK solubles), and fully hydro-treated, and Ethylene-Vinyl-Acetat-copolymer (EVA), and Butylated Hydroxy Toulene (BHT) 0.005% All based on products free from additives of animal origin.</p>
<u>Storage:</u>	<p>Keep in unbroken plastic sealing and away from direct sun and store at max. heat of 40° C / 104° F at relative humidity between 50-70%. Before use you shall strip the outer packaging of the pallets and load the liners on your internal pallets outside your processing area in order to avoid possible contamination to your foodstuffs.</p>
<u>Durability:</u>	<p>The lifetime of the Beck Liner from the day of production is 5 years when stored according to the terms on our product specifications.</p>
